Consent & License. Code of Conduct

Stafford Junction practices four core values: Caring, Honesty, Respect, and Responsibility. Due to the nature of the program, it is not a day care service. The program is staffed by volunteers whose sole responsibility is to provide stimulating activities to youth, preventing summer learning loss. Therefore, misbehavior by students is not tolerated.

The standard disciplinary process is as follows: verbal warning, second verbal warning and parents contacted, two-day suspension from the program and parents contacted, and dismissal from the program.

Exceptions: If a student commits a serious infraction, the Youth Program Manager has the option to immediately dismiss the child from the program.
